<b>What is the overall <a href="#">deductible</a>?</b>	<b>\$3,300</b> /individual or <b>\$6,000</b> /family for In- <a href="#">Network Providers</a> . <b>\$6,000</b> /individual or <b>\$12,000</b> /family for Out-of- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> is not required to be met before the <a href="#">plan</a> begins to pay.
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">Preventive care</a> for In- <a href="#">Network Providers</a> .
